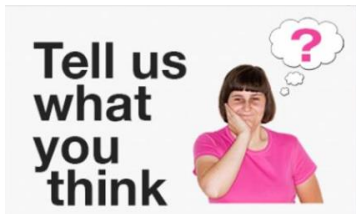
Accountable

A person or group who would have to explain why something that should be happening has not happened.



Community Health and Social Boards work

If we have a National Care Service, there will be new community health and social care boards. They will help run your local support services.



Consultation

Asking people what they think about something and what is important to them. Their answers and opinion then help to make sure the right decisions are made when new plans or changes are being made.



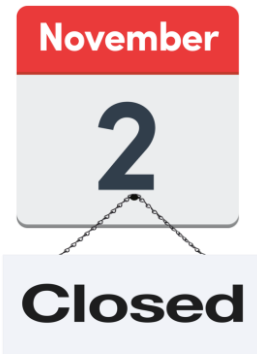
Consistent

When something is done in the same way every time.



Covenant

When different people or groups promise that certain things will or will not be carried out when talking about a certain activity or topic



Closing Date.

The last date you will be able to enter into something. For example entering a competition, or handing in your answers to a survey.



Diversity

Making sure that everyone is included.



Equality

Making sure that everyone is treated equally.

Independent Review of Adult Social Care



This a report that was written so that the Scottish Government could know what was going well and what was not going well with support in Scotland. It also offered ideas that could help make things better in the future, for example a National Care Service.

Sometimes people call it the Feeley Report after the man who wrote it.

Integration Joint Boards



At the moment Integration Joint Boards are responsible for helping Health and Social Care to work in partnership to provide local support services

Law



Rules or ways people must act. If they do not happen the police and courts can take action to make sure it does happen.



Legislation

This is how laws are made. A plan for a law or set of laws can be suggested by the government. Parliament then decide if this can happen or not



Lived Experience

Through your life you have been part of something so you know how it feels as it has happened to you.



Person Centred

The person getting the support should always be at the heart of decisions and plans about their life..

Recommendation

When the best way to do something is suggested by a person or a group.



Responsible

When someone or a group is in charge of making sure something does or does not happen.



Review

When something is looked at closely to see what is going well and what could be better, and to see if any changes are needed.

The Scottish parliament help represent the people of Scotland and make laws and decisions about Scottish government matters. There are 129 members of the Scottish Parliament. They are called MSP's .





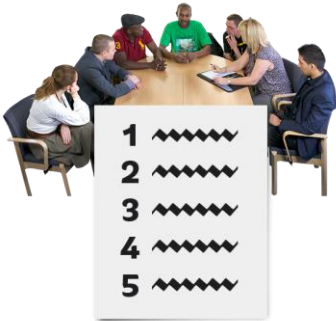
Social Care

Stakeholder

A person who has an interest in something that is being talked about. There can be lots of stakeholders who have an interest in the same thing.

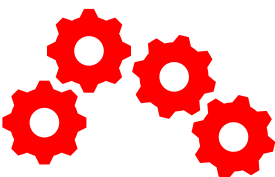


Steering group
